Questions

A question was asked about definition of "wasted water". Mike: water that is not "beneficially used". Beneficial use defined in Rule.

Ben Smith emphasized the importance of cooperative water management.

A question was directed at Mike Gallagher: Are you aware of any pipelines contributing to saltwater intrusion? Mike: No, there have been cases of sea water intrusion in coastal water wells.

Clallam County Comprehensive Plan – Status Update, Holden Fleming, Clallam County (see attached slides)

3:15: Holden Fleming provided an update presentation on the Clallam County Comp Plan Update process. A suggestion was made for County to keep a "tracked changes" version for reviewers to efficiently be able to compare updates to it.

Possible 2025 Drought Preparedness Plan Application – Discussion, Meggan Uecker, City of Sequim

3:38: Background for new drought preparedness standing item: Group decided at an earlier meeting to add Drought Preparedness as a new DRMT "Standing Agenda Item". Any member could provide relevant announcements/updates about 2024 drought preparedness.

Also at a previous DRMT meeting, Meggan suggested that Ecology's Guidance on Local Drought Preparedness Plans (LDPP) could be used as a way to organize drought discussions, and possibly generate content for future LDPP.

DRMT Executive Committee discussed earlier today and recognized that Meggan's LDPP idea would likely need additional time reserved (15-20 min) on the agenda each month and recommended moving it up above the Standing Items. Standing Item section could still be used for updates from members planning for/responding to this year's drought.

3:40: What is a local drought preparedness plan (LDPP)? Meggan reviewed Ecology's guidance for drafting LDPPs. (See LDPP slides attachment).

3:46: What is the Dept. of Ecology grant about and what is the City of Sequim planning on using it for? Megan answers: LDPP grants are specifically for funding development of LDPP's. One of the benefits of having a LDPP is that actions listed in LDPP's could likely get access to future Ecology drought funding. If an entity applies for this grant funding, a project area would need to be defined.
